This is the website of the GIMEx® (gimusicexams). This website contains proprietary notices and copyright information and by using this website, the User agrees to be bound by our Terms and Conditions of Use, as set out here.

Automatic accumulation of information

Students enrolled in an exam or program with GIMEx® are automatically opted in to receive all email / phonically communications. These assist students up to date on:

- Alterations to enrolled & new curriculums and course of study
- Exceptional deals and offers from our industry partners only obtainable to our students
- Additional significant announcements In order to make sure all students are reserved up to date on the activities of the online & offline music exams, we need to be able to communicate through email or contact directly.

GIMEx® ("we", "our", "us") is committed to respecting the privacy rights of its customers, online visitors ("you", "your", "yours"), and other users of the Website ("the Site") referred to herein as related products and services (collectively, "Services"). Accumulation of individual information

We receive and store any information you knowingly provide to us when you create an account, publish content, make a purchase, or fill any online forms on the Website. When required, this information may include the following:

- Personal details such as name, country of residence, etc.
- Contact information such as email address, address, etc.
- Account details such as user name, unique user ID, password, etc.
- Proof of identity such as photocopy of a government ID.
- Payment information such as credit card details, bank details, etc.

MINORS
